	1. Assembly (Non-rigid) – (i.e. apparel/footwear, air/water filters)	
	2. Assembly (Rigid) – (i.e. goods of rigid construction manufactured in a factory, such as appliances, window and door assemblies)	
	3. Building/Construction (e.g. residential homes, multi-family buildings, civil projects such as roads, bridges)	
	4. Consumer/DIY (products used by the consumer around the house/home)	
	5. Electronics (e.g. semi-conductor chips, printed circuit boards, electronic components such as DVDs)	
	6. Medical (e.g. bio-adhesives, used in/on the body)	
	7. Packaging (e.g. corrugated box, flexible packaging)	
	8. Paper Bond (e.g. bookbinding)	
	9. Transportation & Marine (e.g. cars, planes, trucks, marine)	
	10. Tapes – any kind
